Coming Together After Devastating Floods





The Future of the Southbury Training School - Part Two: Southbury Campus BY ED EDELSON

The Southbury Training School (STS) is the largest area in the 69th House District with an uncertain future. During my tenure as First Selectman of Southbury from 2011 to 2015, I worked with state and local partners to create a plan for the future of STS, but progress has since stalled. If elected as your State Representative, I am committed to reviving these efforts and ensuring that the legacy and resources of STS are thoughtfully managed and utilized.



The history of STS dates back to 1937 when the state purchased 1,700 acres to establish a facility for people with intellectual and developmental disabilities (IDD). At its peak, STS housed around 2,300 residents and employed 2,000 staff members, operating on a progressive model that emphasized training residents to live and work outside the institution. In 1986, a decision was made to close STS through moving or death. Currently, about 100 residents remain, and the campus continues to offer essential services to hundreds more with IDD, like a specialized dental program that supports hundreds more people around the state.

As First Selectman, I challenged the conventional wisdom that the future of STS should be left solely to the state. I believed that Southbury and Roxbury should have a direct role in planning, recognizing STS's many assets. I spearheaded the creation of a Governor's Task Force, which made significant progress, including the first comprehensive inventory of STS's buildings and infrastructure. However, changes in leadership slowed momentum, and without continued local advocacy, the task force was eventually disbanded. If elected, I intend to pick up where we left off and advocate for a responsible and innovative future for STS.
